1. **Proprietary Information**

2. **Enquiries**

- 2.2 All the documentation submitted in response to this bid must be in English.
- 2.3 The RTMC may respond to any enquiry in its sole discretion and the bidder acknowledges that it will have no claim against the RTMC on the basis that its bid was disadvantaged by lack of information, or inability to resolve ambiguities.

3. **Validity Period**

Responses to this bid received from bidders will be valid for a period of **120 days** counted from the closing date of the bid.

4. **Supplier Performance Management**

- 4.1 Supplier Performance Management is viewed by the RTMC as critical component in ensuring value for money acquisition and good supplier relations between the RTMC and all its suppliers.
- 4.2 The successful bidder shall upon receipt of written notification of an award, be required to conclude a Service Level Agreement (SLA) with the RTMC, which will form an integral part of the agreement. The SLA will serve as a tool to measure, monitor and assess the supplier's performance level and ensure effective delivery of service, quality and value-add to RTMC business.

5. Instructions on submission of Bids

- 5.1 Bids should be submitted in **Five (5) copies** and one all bound in a sealed envelope endorsed, **RTMC BID 08/2016/17: Appointment of panel of audit firms to render audit services to the RTMC for a period of (3) three years.**
- 5.2 The sealed envelope must be placed in the bid box at the Main Reception area of the RTMC Building, Boardwalk Office Park, Boardwalk Boulevard, Phase 5, Faerie Glen, Pretoria East by no later than **11:00 AM on 03 October 2016.**
- 5.3 A valid tax clearance certificate must be included in the bid response, or proof of application endorsed by SARS in this regard.
- 5.4 The bidder's company name, closing date and the return address must also be endorsed on the envelope.
- 5.5 All bids submitted must be signed by a person or persons duly authorised thereto.
- 5.6 If a courier service company is being used for delivery of the bid document, the bid description must be endorsed on the delivery note/courier packaging to ensure that documents are delivered into the bid box. The RTMC will not be held responsible for any delays where documents are not placed in the bid box before closing time.
- 5.7 Bid received by telegram, telex, email, facsimile or similar medium will not be considered.

- 5.10 Bidders should check the numbers of the pages to satisfy themselves that none are missing or duplicated. No liability will be accepted by RTMC in regard to anything arising from the fact that pages are missing or duplicated.

6. Undertakings by the Bidder

- 6.1 The bidder accepts that all costs incurred in preparation, presentation and any demonstration in relation to this bid shall be for the account of the bidder.
- 6.2 The bidder hereby offer to render all or any of the services described in the attached documents to the RTMC on the terms and conditions and in accordance with the specifications stipulated in this bid documents (and which shall be taken as part of, and incorporated into, this proposal at the prices inserted therein).
- 6.3 The bidder shall prepare for a possible presentation should RTMC require such and the bidder shall be notified thereof no later than 4 (four) days before the actual presentation date. Such presentation may include demonstration of products or services as called for by the RTMC in relation to this bid.
- 6.4 The successful bidder hereby accept full responsibility for the proper execution and fulfilment of all obligations and conditions devolving on him/her under this agreement as the principal(s) liable for the due fulfilment of this contract.
- 6.5 The bidder furthermore confirm that he/she has satisfied himself/herself as to the correctness and validity of his/her bid response that the price(s) and rate(s) quoted cover all the work/item(s) specified in the bid response documents and that the price(s) and rate(s) cover all his/her obligations under a resulting contract and that he/she accept that any mistakes regarding price(s) and calculations will be at his/her risk

7. RTMC's Rights

- 7.1 The RTMC reserves the right not to accept the lowest bid or any bid in part or in whole. RTMC normally awards the contract to the bidder who proves to be fully capable of handling the contract and whose bid is technically acceptable and/or financially advantageous to the RTMC.
- 7.2 The RTMC also reserves the right to award this bid as a whole or in part without furnishing reasons.
- 7.3 The RTMC reserves the right to conduct a site visit at the premises of the offices or at any client sites if so required.

7.4 The RTMC reserves a right to amend any bid conditions, validity period, specifications, or extend the closing date of bid prior to the initially stated closing date. Bidders will be advised in writing of such amendments in good time.

7.5 The RTMC reserves the right to request all relevant information, agreements and other documents to verify information supplied in the bid response. The bidder hereby gives consent to the RTMC to conduct background checks on the bidding entity and any of its directors/trustees/shareholders/members.

8. Supplier Development and Promotion of Emerging Black Owned Service Provider

8.1 The RTMC promotes enterprise development In this regard, successful bidders are encouraged to mentor SMME's and/or Youth owned businesses. The implications of such arrangement will be subject to negotiations between the RTMC and the successful bidder.

8.2 It is also the objective of the RTMC to promote transformation of the South African economy and as such, bidders are encouraged to partner with a black owned entity (being 50%+1 black owned and controlled). Such partnership may include the formation of a Joint Venture and/ or subcontracting agreement etc., where a portion of the work under this bid would be undertaken by black owned entities.

8.3 To give effect to this requirement, bidders are required to submit a partnership/ subcontracting proposal detailing the portion of work to be outsourced, level of involvement of the black owned partner and where relevant, submit a consolidated B-BBEE scorecard in-line with the provisions of the PPPFA Regulations which will be considered as part of the B-BBEE scoring.

12. EVALUATION CRITERIA

The bid will be evaluated on a two stage process. Stage 1 will be on Functionality and Stage 2 will be on Price and B-BBEE (90/10).

Stage 2 will be implemented once the panel has been approved, it will be event based and price proposals will be obtained through Request for quotation process.

(a) Stage 1 – Functionality Evaluation

Stage1 will be on written responses/proposals which consists of **100 points**.

NB: Bidders will be required to score a minimum of **70 points** in order to qualify for Stage 2.

(b) Stage 2 – Price and B-BBEE

NB: Stage 2 will be implemented once the panel has been approved, Request for quotation (RFQ) process will be effected. The RTMC will contact the successful bidders from Stage 1 and tap into the panel to engage with the bidders on Stage 2.

1. Background Information

In Terms of the 2016/17 Internal Audit Plan as approved by the Audit committee, the range of projects cover financial audits, operational audits, performance information audits, compliance reviews and the audit of the Information Technology systems and processes. We are also revisiting the plan in the context of new risk developments.

Our scope also includes the assessment of the efficiency and effectiveness of the computer information systems and also considers related general / application controls. There should also be integration between the IT audits and the financial accounting controls that are reflected on the financial statements.

The IT environment and business operation is continuously evolving at the RTMC. In addressing key significant developments that will change the landscape of the environment of the RTMC, we intend to address all the potential risks in a pro-active and pragmatic manner.

Information relating to road traffic covering areas such as vehicle registration, driver details, infringements, adjudication, enforcement, statistical information, police reports and licence renewals are all maintained on the operating systems used by RTMC and we are also looking at auditing these areas from a financial, compliance and IT perspective where practical and once agreed upon by the stakeholders in the Transport fraternity.

We are looking at securing interest and capacity from partners in driving the above, thereby contributing to the goals of adding value to RTMC and our shareholders through:

- IT audits covering governance, internal control, assurance and data integrity.
- Compliance with PFMA and related legislation.
- Sound financial accounting and GRAP treatment and internal control discipline.
- Proper asset management processes.
- Outsourcing of internal audits based on a project/component specific basis
- Enterprise risk management review, internal audit support and corporate governance.
- Due diligence on systems takeover and digital forensics.

We will agree via a Service Level Agreement to ensure alignment of expectations and continuously engage on scope clarity and modifications where deemed necessary.
